**Membership Categories:** Contributor and General memberships available

**Who Can Join:** All organizations that share the association's vision and mission for interoperability, including:

- Health Information Technology (health IT) suppliers such as Electronic Health Records suppliers, Hospital Information System (HIS) suppliers, etc. and HIT-enabled service suppliers, such as pharmacies, laboratories, etc.
- Health care providers, such as physician offices, post-acute facilities, clinics, hospitals, EMS, etc.
- Other health-focused organizations, including non-profit and private institutes, innovators, governmental entities, HIEs, etc.

**Contributor Members:** Demonstrate commitment to adoption by supporting design, development, application and deployment of technology that would implement the services and comply with CommonWell specifications. This level is intended for organizations that are committed to utilizing services developed through the Alliance.

- Have the ability to participate and vote on substantive issues, policy matters and official positions within the respective Committees prior to final adoption by the Board

**General Members:** Demonstrate commitment to furthering the mission of CommonWell by proposing revisions or new proposals for specifications, test suites and design guidelines. This level is intended for organizations to share complementary perspectives to feed into the evolution of Alliance specifications and policies.

### Benefits

- Have the right to be nominated for and potentially elected onto the Board of Directors, when qualifying Board seats become available
- Have the right to submit proposed revisions or proposals for specifications, test suites and design guidelines of CommonWell
