

Services Fact Sheet

CommonWell Health Alliance[®] and its members are producing and deploying real-world, cross-vendor interoperability services that help contribute to improved health care delivery and outcomes for providers and the people they serve.

Services Available:

CommonWell services are essential to the exchange of health data along the care continuum. Members are committed to building the capability to exchange health data into their software. These real-world CommonWell services include:

- <u>Person Enrollment</u> Enable each individual to be registered and uniquely identified in the CommonWell network
- <u>Record Location</u> Create a "virtual table of contents" that specifies the available locations for patient information
- Patient Identification and Linking Link each individual's clinical records across the care continuum
- <u>Data Query and Retrieval</u> Enable caregivers to search, potentially select and receive needed data across a trusted network

Service Expansion

- In February 2017, 14 CommonWell members committed to building new application programming interfaces (APIs) that will be utilized for a variety of needs across the health and care ecosystem, such as for individuals seeking coverage for disability insurance, for organizations investing in more effective care coordination, or for communities seeking to drive public health programs
- CommonWell built the first set of the Argonaut Project's latest FHIR specifications into its core services making it the first national network to enable comprehensive FHIR-based-exchange at scale
- This will make it easier for developers—both inside and outside the EHR industry—to connect to the information they are trying to access. It also creates the stepping stones for more widespread sharing of discrete segments of data, as opposed to the comprehensive summary of care documents that are shared today

Benefits:

- Members build the capability to exchange health data into their software, enabling providers to work seamlessly within their existing workflow
- Enhanced access, control and convenience for providers and the people they serve
- With one standard interfacing model, vendors and providers can reduce the time and resources devoted to building and maintaining multiple clinical interfaces

Service Provider: Change Healthcare

Service Profiles:

- CommonWell leverages existing standards that members use designed to help enable scalable, secure and reliable interoperability
- Our service provider, Change Healthcare, has built the services around the widely adopted IHE standards (e.g., PIX for patient identity, HL7 FHIR standard with RESTful protocols for record location, and XCA and XDS.b for locating and retrieving patient data)

- CommonWell is one of the first implementers of the FHIR standard for patient identification services extending the FHIR v0.08 spec
- In February of 2017, CommonWell completed building the first set of the Argonaut Project's latest FHIR specifications into its core services—making it the first national network to enable comprehensive FHIR-based-exchange at scale

Patient Matching:

- CommonWell uses traditional demographic information as well as existing external "strong" identifiers such as government-issued IDs. Other industry standard methods for identifying patients are under consideration and will be incorporated as appropriate
- In addition to identifiers, CommonWell members have developed a process that allows individuals to assist in validating potential record linkages to maximize the accuracy of identity matching

Patient Record Queries:

- With the person's permission, all health records regardless of their physical location are linked via a unique "person" identifier that helps providers have access to the total individual's picture
- When providers are searching for a patient's health record on the network, CommonWell-compliant health IT system first identifies the CommonWell Health Alliance "person" record, and then displays all matching "patient" data via the links to local health HIT system records
- The person identification service provided by CommonWell uses a learning algorithm that improves as it discovers information

Service Availability:

- Providers can access CommonWell services via their health IT supplier only if that supplier is a member and they have built the services into their product(s)
- As of March 2018, more than 8,000 provider sites in all 50 states, D.C. and Puerto Rico have gone live with CommonWell Services and have generated more than 115 million queries against our services.
- As of March 2018, more than 80 million patient records are available to providers connected to the CommonWell network, and in those past 12 months, the providers on the CommonWell network have exchanged almost 8 million records, and their usage and engagement continues to expand.

Cost of Services to the Provider: Costs, if any, may be determined by the provider's health information technology vendor (CommonWell member)

- The intent of CommonWell Health Alliance is to reduce the cost of data liquidity by building the capability to exchange health data into providers' software
- CommonWell members are charged for services utilization under an affordable, commodity-like fee structure
- Any pass-through of these charges to providers will be at the discretion of their health IT supplier

Collaboration with Industry:

- CommonWell services leverage existing standards and supplement where needed to facilitate scalable, standards-based interoperability
- CommonWell works with the ONC, HL7 FHIR working groups and relevant standards and profiling organizations to help implement standards in a common and consistent way
- In areas where the standards need to evolve, CommonWell will work with the appropriate organizations and the ONC as needed

Requirements for Service-Utilizing Members:

- Agree to build the capability to exchange health data into their software
- Work with customers to adopt the services and actively register and enroll patients for inclusion in the available document exchange
- Facilitate the submission of documents into the system, as well as retrieve documents from the system
- Consider additional use cases and settings of care as they become available by the Alliance. Changes to the core services that require work for the members are approved by the Board of Directors prior to implementation

Specifications:

On February 22, 2014, CommonWell Health Alliance made its initial specifications available to the general public. This documentation continues to be updated regularly. The Specifications provide detailed information on the initial core services, standards and workflow. These documents are shared publically on the <u>CommonWell Health Alliance website</u> under this <u>license</u>.

- <u>CommonWell Concepts</u> The overarching Concepts document serves as an onboarding tool providing overall key concepts and terms used by CommonWell
- <u>CommonWell Services Specification</u> The Services Specification provides detailed information on the initial core services, specifically the patient identity management, API infrastructure, record locator, and document query and retrieval services. It also outlines the standards used for providing reliable, scalable and secure services
