




WHY COMMONWELL?



Master Person Index (MPI)

The MPI matches patients across care settings and offers both an automated and manual approach to handle patient matching at scale



Data Broker

The Data Broker allows the user to query the CommonWell network and have all the patient's documents returned, removing the need for costly point-to-point connectivity



Record Locator Service (RLS)

The RLS associates the patient across their care locations and allows for one query to identify all of the care locations where the patient has been seen; think of it as a "virtual table of contents"



Trust Network

All CommonWell Service Adopters adhere to the same rules of the road, complete the same certification, and are permitted exchange for specific purposes and therefore engender trust across the network

CommonWell has been building and scaling a nationwide health data exchange network using a highly efficient Master Person Index and Record Locator Service for more than 11 years.

This scale is available today within the CommonWell network, and with access to external frameworks including Carequality and TEFCA. Connected members get immediate access and benefit from consistent and ongoing growth, at no additional cost and with no additional development effort.




One-time fee(s) for onboarding, implementation, and certification
